To make a correction, draw a bold line through the oval and candidate name or ballot measure selection marked by mistake, then fill in the oval next to the correct name. If you voted for the only candidate in a race and want to withdraw that vote, you must request a replacement ballot.

**WARNING:** Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges, or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. State Ballot Measures

Proposition 128 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning parole eligibility for an offender convicted of certain crimes, and, in connection therewith, requiring an offender who is convicted of second degree murder; first degree assault; class 2 felony kidnapping; sexual assault; first degree arson; first degree burglary; or aggravated robbery committed on or after January 1, 2025, to serve 85 percent of the sentence imposed before being eligible for parole, and requiring an offender convicted of any such crime committed on or after January 1, 2025, who was previously convicted of any two crimes of violence, not just those crimes enumerated in this measure, to serve the full sentence imposed before beginning to serve parole?

Proposition 129 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes creating a new veterinary professional associate profession, and, in connection therewith, establishing qualifications including a master's degree in veterinary clinical care or the equivalent as determined by the state board of veterinary medicine to be a veterinary professional associate; requiring registration with the state board; allowing a registered veterinary professional associate to practice veterinary medicine under the supervision of a licensed veterinarian; and making it a misdemeanor to practice as a veterinary professional associate without an active registration?

Proposition 130 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning state funding for peace officer training and support, and, in connection therewith, directing the legislature to appropriate 350 million dollars to the peace officer training and support fund for municipal and county law enforcement agencies to hire and retain peace officers; allowing the fund to be used for pay, bonuses, initial and continuing education and training, and a death benefit for a peace officer, police, fire and first responder killed in the line of duty; and requiring the funding to supplement existing appropriations?

Proposition 131 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes creating new election processes for certain federal and state offices, and, in connection therewith, creating a new all-candidate primary election for U.S. Senate, U.S. House of Representatives, governor, attorney general, secretary of state, treasurer, CU board of regents, state board of education, and the Colorado state legislature; allowing voters to vote for any one candidate per office, regardless of the voter's or candidate's political party affiliation; providing that the four candidates for each office who receive the most votes advance to the general election; and in the general election, allowing voters to rank candidates for each office on their ballot, adopting a process for how the ranked votes are tallied, and determining the winner to be the candidate with the highest number of votes in the final tally?

CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT ISSUE #6A OPERATING MILL LEVY

SHALL CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT TAXES BE INCREASED UP TO \$1.15 MILLION ANNUALLY (FOR COLLECTION IN CALENDAR YEAR 2025) AND BY SUCH ADDITIONAL AMOUNTS RAISED ANNUALLY THEREAFTER BY AN AD VALOREM PROPERTY TAX IMPOSED AT A RATE OF FOUR (4) MILLS IN ORDER TO MEET INCREASING OPERATIONAL COSTS AND TO PROVIDE RECREATIONAL PROGRAMS AND SERVICES (INCLUDING BUT NOT LIMITED TO THE OPERATION OF A SWIMMING POOL); AND SHALL THE DISTRICT BE ALLOWED TO RETAIN AND SPEND PROPERTY TAX REVENUE ABOVE ANNUAL LIMITS WHICH MIGHT OTHERWISE APPLY OR BE PROPOSED, INCLUDING AS AN APPROVED EXCEPTION TO THE LIMITATION SET FORTH IN SECTION 29-1-301 OF THE COLORADO REVISED STATUTES?

CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT ISSUE #6B POOL DEBT FINANCING

SHALL CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT DEBT BE INCREASED UP TO \$24.8 MILLION, WITH A MAXIMUM REPAYMENT COST OF UP TO \$44 MILLION, AND SHALL DISTRICT TAXES BE INCREASED UP TO \$1.68 MILLION ANNUALLY IF NECESSARY, BUT ONLY AFTER THE APPLICATION OF DEDICATED SALES AND USE TAX REVENUES RECEIVED FROM THE CITY OF CAÑON CITY TO REPAY THE DEBT, ALL FOR THE PURPOSE OF FINANCING THE COSTS OF CONSTRUCTING AND EQUIPPING A NEW COMMUNITY RECREATION POOL TO REPLACE THE DISTRICTS PRIOR SWIMMING POOL WHICH WAS PERMANENTLY CLOSED, SUCH DEBT TO CONSIST OF THE ISSUANCE AND PAYMENT OF GENERAL OBLIGATION BONDS WHICH SHALL BEAR INTEREST AT A MAXIMUM NET EFFECTIVE INTEREST RATE NOT TO EXCEED 5.5% PER ANNUM AND BE ISSUED AT SUCH TIMES AND PRICES (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT HERewith, AS THE BOARD OF DIRECTORS MAY DETERMINE, PROVIDED THAT ISSUANCE OF DEBT AUTHORIZED BY THIS BALLOT MEASURE SHALL BE CONDITIONED UPON PRIOR VOTER APPROVAL OF A BALLOT MEASURE AUTHORIZING THE CITY OF CAÑON CITY DEDICATED SALES AND USE TAX; SHALL AD VALOREM PROPERTY TAXES BE LEVIED, IF NECESSARY, WITHOUT LIMIT AS TO THE MILL RATE TO GENERATE AMOUNTS SUFFICIENT IN EACH YEAR TO PAY THE PRINCIPAL OF, PREMIUM IF ANY, AND INTEREST ON SUCH DEBT BUT ONLY AFTER THE APPLICATION OF DEDICATED SALES AND USE TAX REVENUES RECEIVED FROM THE CITY OF CAÑON CITY; AND SHALL THE DEDICATED REVENUES RECEIVED FROM THE CITY OF CAÑON CITY AND ANY EARNINGS FROM THE INVESTMENT OF SUCH REVENUES AND THE PROCEEDS OF THE BONDS CONSTITUTE A VOTER-APPROVED REVENUE CHANGE UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION?

CITY OF CAÑON CITY ISSUE #2A SALES AND USE TAX INCREASE FOR COMMUNITY POOL

SHALL THE CITY OF CAÑON CITY TAXES BE INCREASED BY \$1,680,000 ANNUALLY AND BY WHATEVER AMOUNT IS GENERATED THEREAFTER FROM A TEMPORARY SALES AND USE TAX IMPOSED AT THE RATE OF THREE-TENTHS OF ONE PERCENT (0.30%) TO BEGIN ON JANUARY 1, 2025 AND TO END ON DECEMBER 31, 2050, TO BE PLEDGED SOLELY TO SUPPORT FINANCING FOR THE CONSTRUCTION OF A COMMUNITY RECREATION POOL AND RELATED POOL CAPITAL IMPROVEMENTS CONSTRUCTED AND OPERATED BY THE CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT (THE "RECREATION DISTRICT") AND LOCATED ON LAND DONATED BY FREMONT RE-1 SCHOOL DISTRICT; SHALL THE TAX INCREASE AUTHORIZED HEREIN BE SUBJECT TO AND CONDITIONED UPON PRIOR VOTER APPROVAL OF A BALLOT MEASURE AUTHORIZING DEBT TO BE ISSUED BY THE RECREATION DISTRICT; SHALL CITY OF CAÑON CITY AND THE RECREATION DISTRICT BE AUTHORIZED TO ENTER INTO AN AGREEMENT CREATING FINANCIAL OBLIGATIONS EXTENDING BEYOND THE CURRENT FISCAL YEAR TO PAY OVER THE PLEDGED REVENUES TO THE RECREATION DISTRICT; AND SHALL THESE PLEDGED REVENUES BE COLLECTED, RETAINED AND SPENT AS A VOTER APPROVED REVENUE CHANGE OF THE CITY NOTWITHSTANDING ANY REVENUE LIMITS PROVIDED BY LAW?
